The information that you give us

As part of the admission of your son/daughter/dependant to the College we may collect parent/carer/guardian details including: parent/carer/guardian name, emergency contact telephone number and email address. Where required we shall also collect personal information in connection with applications for funding (I.e. When a child needs school meals, bursary, etc.)

The uses made of your personal information

We use your information to keep you informed about the progress your child. We also keep this information so we can contact you in case of emergency. In addition, we will contact you to ask for feedback about the College so we can make improvements to the services we deliver.

The legal basis on which we collect and use your personal information

Generally, the information is processed as part of our public interest task of providing education to your son/daughter/dependant.

How long we keep your personal information.

- Unsuccessful application of your son/daughter/dependant Current academic year + 6 months
- Successful application of your son/daughter/dependant End of student relationship + 6 years

How we share your personal information.

We will share your information internally and to third parties who provide administrative, legal and accountancy services to the college to enable us to manage and administer your son/daughter/dependant's education effectively. We use a 'permissions' system to make sure that staff only have access to the information they need to carry out their jobs.

The college reserves the right to review, change, add, and withdraw suppliers and the extent of their services without prior consultation, where such changes do not have any material impact on your personal information or your rights.

How we transfer your personal information outside Europe

Where you register on an event with the college, whether a prospective or current student or relation, your details including name, address, email address, phone, emergency contact details, access information, travel requests, courses preferences will be stored in Eventbrite to administer the event. This is stored in the US and under the EU-US Privacy Shield Framework showing compliance to GDPR.

College Data is backed up to https://www.backblaze.com for the purposes of Disaster Recovery. This is stored in the US and under the EU-US Privacy Shield Framework showing compliance to GDPR. The data is secured with 256 bit AES encryption

Your rights over your personal information

You have a number of rights over your personal information, which are:

- the right, where our use of your personal information is carried out for the purposes of an agreement with us and is carried out by automated means, to ask us to provide you with a copy of your personal information in a structured, commonly-used, machine-readable format.
